

Twitter Contest Giveaway Rules '

NO PURCHASE IS NECESSARY TO ENTER OR WIN. '

1. Eligibility: This giveaway is open only to those who have a valid Laurier ID number, reside in Ontario. Employees of Wilfrid Laurier University, its affiliates, advertising and promotion agencies (collectively the "Employees"), and immediate family members (parent, child, sibling or spouse) are not eligible to participate in the giveaway. The giveaway is subject to all applicable federal, provincial, and local laws and regulations and is void where prohibited.

2. Agreement to Rules: By participating, the Participant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of Wilfrid Laurier University as final and binding as it relates to the content of this giveaway.

3. Giveaway Period: Entries will be accepted online starting on November 14, 2019 at 12:01 am EST and ending on December 13, 2019 at 11:59 pm EST. All online entries must be received by December 13, 2019 at 11:59 pm EST.

4. How to Enter: The giveaway must be entered by following @LaurierIThelp on Twitter and completing a short IT Support Questionnaire. The entry must fulfill all giveaway requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Wilfrid Laurier University. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If Winner cannot be contacted, is ineligible, fails to claim the prize within five (5) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected.
